## **APPLICATION INSTRUCTIONS**

#### SUBSTRATE PREPARATION

#### Concrete Court

All concrete courts must have waterproof membrane. Allow new concrete surface to cure for 28 days. The concrete should have a wood float or broom finish. Under no circumstances should a steel trowel be used. The concrete should be additive-free and a curing membrane must not be applied to the finished surface.

All dirt, dust and foreign matter should be removed completely from the surface to be applied. Apply a coat of Sikalastic<sup>®</sup>-500 Acrylic Primer AP (formerly Davco<sup>®</sup> Acrylic Primer) or equivalent acrylic primer by soft broom. Allow about 2 hours for it to dry.

#### APPLICATION

Pour 15 cm - 23 cm ribbon parallel to one of the directions of the surface.

**Sikafloor®-2045 Courtkote** March 2025, Version 02.01 020813020010000071 Spread coating evenly with a soft rubber edge squeegee by walking in one direction and then reverse the direction. Do not "overwork" and always maintain a wet edge.

After drying, inspect the coating and scrape off any ridges, lumps or other foreign matter. Then apply another uniform coat perpendicular to previous application.

The final coat is to be spread in the same direction as the first coat.

Allow a minimum of 4 hours between each coat. Court will be ready for use 24 hours after final coat. If the final colour finish does not appear to be completely even, apply 1 or 2 coats of Sikafloor®-2045 Courtkote only to give a homogeneous colour finish. Ensure the whole process of application and curing is protected from rain.

#### **CLEANING OF TOOLS**

Use water to clean up tools and equipments immediately after use.
